Minutes: Benjamin Wuethrich

Meeting called to order at 7.03 pm

1. Approval of minutes from March 2nd, 2023

Minutes were updated to reflect that Philippe was present.

2. Action items update from enter last meeting date here

- Benjamin will be added as a signer for the cheques – not yet, in progress
- all: send things to Heidy to be included in the TellTale – not yet due
- Heidy: to follow up with the request to write something regarding a thank you note for Paola's services – done
- Charlotte: to announce the AGM on Facebook – past due anyway
- Auggie: ask Noemie about the Cashboxes and if possible pick up everything from here with connection to the Amicale Romande/Swiss Club to bring to the storage – some things were transferred at theatre, but Noemi still has a few things
- Auggie or Charlotte: announce the Theatre on facebook – done / past due
- Insurance coverage - depends on whether we ever serve booze, like at the raclette
- Nadia to be added as signer of the cheques – done / no longer relevant

Remark from Paula at this point: The place where we used to have soccer and the raclette has been sold to the city of Oakville, in case we need a venue

3. General remarks by the president

- Swiss National Day:
 - Hansa Haus is booked, food, tents etc.; can we bring our own tent? For bad (or very hot) weather, we have the inside
 - If somebody becomes a member of the German Club, we get 10% off the bill (would be \$320 off)
 - German Club is also interested in doing joint social events
 - 600 Nussgipfel, we have a magician
 - Embassy has been notified
 - Canadysli have been asked to play, they'll get back to us
 - Still need volunteers and sponsorship
 - Auggie's family might be visit and volunteer
 - Should it be free again? Yes, but maybe increase margin on Nussgipfel; charging a fee requires very dedicated people to collect; could have a donation box; could charge for guests, but then how do you identify them—decision: "free for members", encourage non-members to become members or donate something
 - A membership desk where you can renew or sign up; if we have e-Transfer by then, things would be easier (we get it with the signatory / bank update)
 - Are we going to have vendors? Alpine (formerly HUH) is working with Hansa Haus, we don't have to do anything; Charlotte doesn't know anybody, but maybe people reach out; in the past, we didn't charge for

tables (and we had seven or eight vendors); we're open to it, but not actively looking

- SCCC asked if we can do the May Social as a joint event (yes)
- Somebody reached out with the rights to a Swiss movie and asked if we want to do a screening; fees would be 600–1000 Euro(!) which seems pretty steep
 - Options: negotiate better price, or reach out to Embassy and see if they could support it somehow
 - We could show it at the French Club, or a public library
- July 27: international soccer/food/music event by FC Forge (Hamilton soccer team), would we be interested in joining? We wouldn't have to pay, just sell tickets at \$20; decision: we can promote, but not actively participate (too close to National Day)
- Where do we draw the line for what we post on social and what we advertise? We used to have quite a few ads in the Tell Tale, but it was a lot of work. We can be a bit picky and for example give preference to members, and/or ask the SCCC to post themselves on Facebook. We can also nudge them to be more clear about why this has a connection to the Swiss Club, if it's not obvious from the posting.

4. Treasurer's report

- Number one priority: update TD bank account; we need minimum two signatories, but we should have at least one spare; currently: Auggie, Albert, Thomas; suggesting: adding Heidi and Ben to replace Albert and Thomas; need to coordinate with Albert because we need two signatories to approve the new signatories
Update is also going to give us visibility into our account, e-Transfer, and just generally makes things simpler
- We have paid out a lot of money already, including invoice for board dinner and AGM (already spent almost \$10k), membership fees are trickling in
- Grant request from theatre group (\$2000): group doesn't spend money on rehearsal, and there were 70 people attending, and in the past, the section used to have a \$2k deficit already in the past, but they have some funds leftover from previously. Generally, the cost of things have gone up, and the grant is higher than what Auggie remembers, but it's also "very Swiss". Wide approval for grant. Payment once we have sorted out the bank account.

5. Membership report

- Send invoice with next printed Tell Tale? Generally, think about a solution, but yes, send invoices to Heidi
- Elisabeth Evans paid \$40, but she's a lifetime member now, who can reach out?

 - West end Kafiklatsch going well, good system in place to know when people move into nursing home

 - Are the horse race events still a thing? There's no more buffet, and a lot of things have changed
